A. Call to order

Secretary Spado called the meeting to order at 6:30 p.m.

B. Salutation to the United States Flag.

In the absence of Alessio and Spadafore, and on behalf of the Board, Scavone wished Dailey, Liverpool Public Library Director well and thanked her for many years of dedicated service to the library. Dailey was director since 2002. A reception followed.
